BURSARY PROGRAMME FOR EMPLOYEES' CHILDREN

United Malacca Berhad (UMB) offers a bursary programme to assist children of employees pursuing degree course study at Malaysian public universities.

The children of eligible employees may apply for a bursary based on the terms and conditions below.

1. Eligibility Requirements

- (a) The Applicant shall be Malaysian.
- (b) The Applicant possesses a minimum CGPA of 2.50 for STPM/ Pre-University/ Foundation/ Local Matriculation/ Diploma or a minimum of 5 credits for SPM 2024.
- (c) The Applicant's parent must be a full-time employee with UMB or its subsidiaries in Malaysia (UMB Group Malaysia), with gross employment income not exceeding RM3,000 per month, and has been working for UMB Group Malaysia, for at least five (5) continuous years.
- (d) The Applicant is the employee's natural-born child, adopted child, or stepchild.
- (e) The Applicant is not bonded, holds other scholarships, or receives financial assistance from any other organisation.

2. Accepted Fields of Study

UMB accepts all fields of degree course study.

3. Accepted Universities

Malaysian public universities

4. Value of Bursary

- (a) The bursary award covers **tuition fees and living expenses only**, following **the amount charged** by the university to the undergraduate, but **shall not exceed the sum of RM5,000 per academic year**, commencing from Year 1 until the Final Year of the degree course study. The bursary shall be disbursed at the commencement of the first semester of each academic year.

- (b) The bursary award is subject to an offer by UMB, execution of an agreement by the bursary recipient as acceptance of the bursary award, and completion of all enrolment and admission requirements at the respective Malaysian public university.
- (c) The bursary award is only valid for the duration of the degree course study applied and shall not cover any extension of the programme beyond its minimum duration.

5. Service Bond Period

Bursary recipients are not required to serve a bonded period with UMB Group of Companies after the completion of course study.

6. Application

The Applicant may fill out the application form (downloadable from UMB website at <https://unitedmalacca.com.my> and submit the form and all necessary documents to UMB Head Office.

7. Other Provisions

- (a) The bursary is given at the sole discretion of UMB. Applicants are not guaranteed approval of the bursary notwithstanding fulfilling the conditions set.
- (b) If the bursary recipient withdraws from the degree course study, or is suspended/expelled by the university at any point of time before the completion of the course study, the bursary award shall terminate and be automatically revoked. UMB reserves the right to require the recipient to reimburse the bursary's total value in such a situation.
- (c) The bursary recipient shall supply UMB with a copy of his/her examination results for every term or semester of each academic year within seven (7) days of receiving notification of the examination result.
- (d) UMB reserves the right to amend any criteria and/or terms and conditions of the bursary programme as and when it deems necessary or to terminate this scheme at any time as it deems appropriate. The decision of UMB on all matters regarding the bursary award is absolute and final.
